Residential LED Lamps	<ul style="list-style-type: none"> <li>• Lower of \$8 per lamp/fixture or 50% of the lamp/fixture cost</li> <li>• Member-owner account cap of 50 lamps per year.</li> </ul>	<ul style="list-style-type: none"> <li>• LED light bulbs, lamps or fixtures 500 lumens or greater.</li> <li>• Medium, GU24 or other residential/light commercial oriented base.</li> <li>• Multi-LED light sources i.e. rope-light, LED troffers, or under-counter lighting are considered a single fixture.</li> </ul>

Outdoor Power Equipment Electrification	<ul style="list-style-type: none"> <li>• 25% of cost up to \$150</li> <li>• 25% of cost up to \$50</li> </ul> <p>Minimum purchase price of \$50</p> <p>New equipment only</p>	<ul style="list-style-type: none"> <li>• Electric Mowers or snow blowers.</li> <li>• Electric Trimmers, chainsaws, blowers, pruners or power-washers.</li> </ul> <p>Battery or corded equipment as defined above</p> <p>36 volt minimum on mowers or snow blowers</p> <p>18 volt minimum on all other equipment</p>
Energy Star® Rated Split System Air-Conditioners	<ul style="list-style-type: none"> <li>• \$100 per unit</li> <li>• Minimum 16 SEER</li> </ul>	<ul style="list-style-type: none"> <li>• Minimum equipment size is 1 ton.</li> <li>• Window units do not qualify.</li> <li>• A list of qualifying equipment is available at <a href="http://www.ceedirectory.org">www.ceedirectory.org</a></li> </ul>
Electric Water Heaters and Air Source Heat Pump Water Heaters	<ul style="list-style-type: none"> <li>• \$30 per basic unit, 30 to 55 gallon only</li> <li>• additional \$20 per unit incentive for lifetime tank warranty</li> <li>• \$350 per unit for Air Source Heat Pump powered, 30 gallon minimum</li> </ul>	<ul style="list-style-type: none"> <li>• Energy Star® Rating only required for Air Source Heat Pump Water Heaters.</li> <li>• Applies to residential or commercial installations.</li> </ul>
Electric Heat Pump: Air Source	<ul style="list-style-type: none"> <li>• \$300 per ton for units rated from 15 to 17 SEER.</li> <li>• \$450 per ton for units greater than 17 SEER.</li> <li>• \$100 per unit additional incentive for central air source with integrated controlled ETS backup in lieu of a separate ETS incentive.</li> <li>• \$85 per through the wall or window-mounted Air Source Heat Pumps.</li> </ul>	<ul style="list-style-type: none"> <li>• Minimum 15 SEER</li> <li>• Energy Star® Rating not required</li> </ul> <p>• Minimum qualifying load for through the wall heat pumps is 12,000 BTU/hour capacity.</p>
Electric Heat Pump: Central Ground Source	<ul style="list-style-type: none"> <li>• \$500 per ton for new installations</li> <li>• \$250 per ton for replacement systems.</li> </ul>	<ul style="list-style-type: none"> <li>• Energy Star® Rating not required.</li> <li>• Ground Source closed loop or open water source.</li> </ul>

Commercial LED Lighting	<ul style="list-style-type: none"> <li>• Pre-set amount by fixture type.</li> <li>• Pole mounted lighting cap of \$20,000 or 25% of total LED head cost per project/account.</li> <li>• Refrigerated case lighting cap of \$3,000 or 50% of total LED fixture cost per project/account.</li> <li>• All other retrofit or new construction fixture types have a combined cap of \$20,000 or 50% of LED fixture cost, per project/account.</li> </ul>	<ul style="list-style-type: none"> <li>• Includes exterior wall mounted lighting, exterior pole mounted lighting, refrigerated case lighting, and interior lighting.</li> <li>• For both new construction and retrofits.</li> <li>• One project per category, per year, per Member-Owner account. Project Cap of \$20,000.</li> <li>• Reach-in cases: \$60 per door.</li> </ul>
Commercial LED T-12 Retrofits	<ul style="list-style-type: none"> <li>• Lower of 50% of lighting equipment costs OR as outlined on Rebate Application Form.</li> </ul>	<ul style="list-style-type: none"> <li>• Project cap of \$20,000.</li> <li>• Only T-12 removal/replacement qualifies.</li> </ul>
Electric Vehicle (EV) Charging Equipment Rebates	<ul style="list-style-type: none"> <li>• 50% of EV charging equipment.</li> <li>• 50% of electric service installation.</li> <li>• Direct Current Fast Charger (DCFC) 50% of equipment/installation up to \$3,000 - 50 kW output; up to \$5,000 for 100 kW and larger output.</li> </ul>	<ul style="list-style-type: none"> <li>• Level 2 Chargers (no network capability) up to \$250 each for equipment and electric service installation for Residential or Commercial - Private Fleet uses only.</li> <li>• Level 2 Chargers (with network capability) up to \$1,000 each for equipment and electric service installation and must be accessible to General Public.</li> <li>• DCFC incentives for public accessible installations only.</li> </ul>
Commercial and Industrial Motors	<ul style="list-style-type: none"> <li>• \$8 per horsepower (hp).</li> <li>• \$1.50/hp wiring assistance if the motor replaces a fossil-fueled engine, or is a new installation.</li> </ul>	<ul style="list-style-type: none"> <li>• Motor sizes 10 through 1,500hp.</li> <li>• Motor must be new and cannot be re-wound or moved from another location.</li> </ul>
Variable Speed Drive or Variable Frequency Drive (VSD or VFD) retrofits	<ul style="list-style-type: none"> <li>• Sliding scale from \$1,600 to \$6,800</li> <li>• Based on motor horsepower.</li> <li>• Cap of 50% of the VSD/VFD unit costs.</li> <li>• Per project cap of \$20,000.</li> </ul>	<ul style="list-style-type: none"> <li>• Motor sizes from 25hp and larger.</li> <li>• Applies to irrigation, farm, commercial and industrial applications.</li> <li>• Only retrofits to existing installations qualify.</li> <li>• Replacement of existing VSD/VFDs does not qualify.</li> </ul>

### IMPORTANT INFORMATION

- For all rebates, other than Commercial LED lighting, member must apply within **120 days of purchase.**
- Member must bring in receipts, boxes, and if applicable, the Energy Star® tag from appliance.
- Commercial LED Lighting Projects
  - member must contact our office prior to start of project to begin a pre-inspection.
  - member must apply within **120 days of completion.**
  - member must contact our office to schedule a post-inspection.
