Residential LED Lamps and fixtures	<ul style="list-style-type: none"> • 50% of lamp or fixture cost. • Capped at \$8 per lamp or fixture. • Member-owner account cap of 50 lamps per year. 	<ul style="list-style-type: none"> • LED light bulbs, lamps or fixtures 500 lumens or greater. • Medium, GU24 or other residential/light commercial oriented base or fixtures with integrated LEDs. • Fixtures with multi-LED light sources (rope-light, or under-counter lighting) are designated as one fixture.
Energy Star® appliances, induction cooktops, refrigerator and freezers	<ul style="list-style-type: none"> • \$30 per unit for: <ul style="list-style-type: none"> • refrigerators or freezers (full-size) • top load clothes washers • clothes dryers (electric only) • \$40 per unit for front load clothes washers. • \$90 per unit for heat pump clothes dryer (vent-less). • \$100 per unit - induction cooktop replacing electric. • \$350/unit for induction cooktop replacing propane or natural gas or for new construction. 	<ul style="list-style-type: none"> • Eligible appliances include: induction cooktops, refrigerators, freezers, clothes washers, clothes dryers. • Full-size refrigerators and freezers considered full-size at 7.75 cubic feet or greater. • Must be Energy Star® rated (exception are induction cooktops which must have minimum surface width of 30 inches to qualify). A list of qualifying equipment is available at www.energystar.gov. • Invoice and photo for each unit of old propane or natural gas unit required.
Outdoor Power Equipment Electrification (Additional batteries purchased with, and for qualifying equipment, can be included with original purchase rebate application. Replacement or battery-only purchases are not eligible.)	<ul style="list-style-type: none"> • 25% of cost up to \$50 for trimmers, leaf blowers, and power-washers. • 25% of cost up to \$100 for chainsaws. • 25% of cost up to \$150 for e-bikes, snow blowers, walk-behind mowers. • 25% of cost up to \$1,000 for electric riding mowers. • 50% cost up to \$25 for additional batteries with original purchase/application. 	<ul style="list-style-type: none"> • Minimum purchase price of \$50. • New equipment only. • Members limited to one rebate per product except for e-bikes. • An aggregated maximum rebate of \$300 per member account excludes riding lawn mowers. • Battery and corded electric equipment only. • Other than electric bikes, members are limited to one rebate per product type per year.
Commercial and industrial motors	<ul style="list-style-type: none"> • \$8 per hp • \$1.50 per hp wiring assistance if the motor replaces a fossil-fueled engine, or is a new installation. • \$20,000 cap per project. 	<ul style="list-style-type: none"> • New or replacement electric motors from 10 hp to 1,500 hp. • Commercial and industrial motors only. • Used and rewound motors are not eligible
Electric resistance and heat-pump water heaters	<ul style="list-style-type: none"> • 30 gallon minimum size requirement • Heat-pump units must be Energy Star® rated. 	<ul style="list-style-type: none"> • \$30/electric resistance heater - new construction • \$50/electric resistance heater - (must be switching from propane/natural gas) • \$350/unit for air source heat-pump units
Electric heat pump: Air-source	<ul style="list-style-type: none"> • Tier 1 \$675 <= 2tons and \$1,800 > 2 tons. • Tier 2 \$1,000 <= 2 tons and \$2,400 > 2 tons. • \$450/ton air-to-water units with EER>=19 and COP >=4. • Incentive amount is the lower of stated rebate or 50% of equipment cost. 	<ul style="list-style-type: none"> • Tier 1 (Standard ASHP) required HSPF >= 9.0 and SEER >= 15. • Tier 2 (Cold-Climate Certified ASHP) required HSPF >= 10.0 AND SEER >= 16. • Energy Star® rating not required
Electric heat pump: Ground-source	<ul style="list-style-type: none"> • \$500/ ton for new installations. • \$250/ton for existing unit replacements. • Energy Star® rating not required. 	<ul style="list-style-type: none"> • New or replacement ground source heat pumps with closed-loop or open-loop water source heat pumps qualify.

Commercial LED lighting	<ul style="list-style-type: none"> • Pole mounted lighting cap of \$20,000 or 25% of total LED head cost per project/account. • Refrigerated case lighting cap of \$3,000 or 50% of total LED fixture cost per project/account. • All other retrofit or new construction fixture /bulb types have a combined cap of \$20,000 or 50% of LED fixture cost. 	<ul style="list-style-type: none"> • Includes exterior wall mounted lighting, exterior pole mounted lighting, refrigerated case lighting, and interior lighting. • For both new construction and retrofits. • Design Lights Consortium certification required. • One project per category, per year, per member-owner account. • Pre-set incentive amount by fixture type.
Electric vehicle chargers	<ul style="list-style-type: none"> • Installations must comply with all applicable building and electric codes. • All equipment and installation costs are required to be submitted on one application. • One rebate per installed charger; multiple charge ports do not qualify for multiple rebates. 	<p><u>Level 2 (L2) - No retail sale or fee collection capability.</u></p> <ul style="list-style-type: none"> • 50% of total equipment and installation costs up to \$500 for non-managed chargers. • 50% of total equipment and installation costs up to \$1,000 for managed chargers. <p><u>DCFC and L2 - Retail sale or fee collection capable.</u></p> <ul style="list-style-type: none"> • 50% of total equipment and installation costs up to \$1,000 for L2. • 50% of total equipment and installation costs up to \$3,000 for DCFC rated between 50-75 kW. • 50% of total equipment and installation costs up to \$5,000 for DCFC rated between 76-149 kW. • 50% of total equipment and installation costs up to \$7,500 for DCFC rated 150 kW and above.
Smart Thermostat	<ul style="list-style-type: none"> • \$25 per thermostat • Thermostat must be WiFi network capable and installed at member consumer account location. 	<ul style="list-style-type: none"> • Limit of 2 thermostats per member account for standard/low-voltage applications. • Limit of 5 thermostats per member account for line-voltage applications.
Whole house fan	<ul style="list-style-type: none"> • \$100 per unit. 	<ul style="list-style-type: none"> • Replacement or new installations. • Attic ventilation systems do not qualify.
Variable speed drive (VSD)	<ul style="list-style-type: none"> • Sliding scale from \$1,600 to \$6,800 • Based on motor horsepower. • Cap of 50% of the VSD equipment costs. • Per project cap of \$20,000. 	<ul style="list-style-type: none"> • Electric motor sizes - 25hp and larger. • Applies to irrigation, farm, commercial and industrial users. • New and retrofit installations only, no maintenance replacements.

IMPORTANT INFORMATION

- For all rebates, other than Commercial LED lighting, member must apply within 90 days of purchase.
- Member must bring in receipts, boxes, and if applicable, the Energy Star® tag from appliance.
- Commercial LED Lighting Projects
 - member must contact our office prior to start of project to begin a pre-inspection.
 - member must apply within 90 days of completion.
 - member must contact our office to schedule a post-inspection.
