The meeting was called to order at 1:55 p.m. by Anne L Dorough, President.

MANAGER'S REPORT

Manager Herrera reported on the expenditure check register totaling \$834,688.25 for July 2019.

Manager Herrera reported on the American Express and MasterCard credit card expenditures, with supporting receipts, as made available to the Board of Trustees for July 2019.

Manager Herrera reported in the Engineering Report for July that SEC had 43 site visits for the month and that our consulting engineers were conducting the final review of SEC's coordination study. Manager Herrera answered questions posed by the Trustees.

Manager Herrera concluded by reporting that SEC had been contacted by White Sands Missile Range (WSMR) about being a subcontractor to provide raptor protection to all SEC poles located at WSMR. Manager Herrera stated that the project would take until 2024 before all poles could be completed at WSMR. Manager Herrera provided the Board of Trustees with information on the meeting that Donald Monette had requested at the July 24, 2019 Board meeting. Manager Herrera stated that SEC had received several thank you notes.

OPERATIONS AND MAINTENANCE REPORT

CONSTRUCTION/MAINTENANCE REPORT

Manager Herrera stated that due to an outage on the feed coming from Tucson Electric Power at the Quemado Substation, he would be providing the Construction/Maintenance and Outage

Reports for Ricky Williams. Manager Herrera mentioned that due to this outage, all of the West area is now being fed out of the Magdalena substation, but SEC was lucky enough to get parts to fix the problem which is where Ricky Williams is at currently helping crews. Manager Herrera reported for July that crews completed 30 work orders and closed 35 work orders. Manager Herrera stated that 50 service orders were completed with 16 of them being for area light issues. Manager Herrera reported that crews documented that 83 trees had been trimmed and documented 67 trees that had been removed from SEC's right-of-way's; and proceeded to answer questions posed by the Trustees.

OUTAGE REPORTS

Manager Herrera gave a review of the Cooperative Response Center (CRC) Outage Report for July 2019, stating 47 outage reports had been turned in by SEC crews. Manager Herrera answered questions posed by the Trustees.

President Dorough thanked Manager Herrera for the Operations and Maintenance Report for July 2019.

FINANCE COMMITTEE REPORT

Trustee Aguilar reported on the Finance Committee Meetings held on July 24, 2019.

President Dorough thanked Trustee Aguilar for the Finance Committee Report.

STANDING COMMITTEE REPORT

Trustee Anaya reported on the Standing Committee Meeting held on August 21, 2019, with recommendations to the full Board of Trustees.

President Dorough thanked Trustee Anaya for the Standing Committee Report.

NEW BUSINESS

2017 Bad Debt Write-off Resolution

Manager Herrera reported that the Bad Debt write-off for 2017 was \$70,928.51 for Energy Accounts and \$5,520.69 for Other Accounts Receivable (OAR) Accounts. Manager Herrera stated that SEC still tries to collect on these accounts, but this is for accounting and auditing purposes. Manager Herrera noted that it was the recommendation of the Finance Committee to approve the 2017 Bad Debt Write-off Resolution.

After discussion, Trustee Wolberg made a motion to accept the Finance Committee's recommendation to approve the write-off of \$70,928.51 for Energy Accounts and \$5,520.69 for Other Accounts Receivable accounts in bad debt for the year 2017; motion seconded by Trustee Anaya. Motion carried unanimously. (copy of Resolution attached hereto and made a part hereof)

1993 Capital Credits General Retirement

Manager Herrera reported that SEC is on a 25-year retirement cycle for allocated Patronage Capital with 1993 being up for retirement. Manager Herrera stated that it was the recommendation of the Finance Committee to approve the 1993 Capital Credits General Retirement of \$367,600.01.

After discussion, Trustee Wolberg made a motion to accept the Finance Committee's recommendation to approve the 1993 General Retirement of \$367,600.01 being payable on December 1, 2019, if it is fiscally responsible at that time; motion seconded by Trustee Anaya. Motion carried unanimously.

Pole Attachment License Agreement

Manager Herrera reported that Socorro Consolidated Schools received a grant to allow them to bring fiber to the Midway and San Antonio schools and the schools are requesting permission to attach to about 300 poles. Manager Herrera stated that Pole Attachment License Agreement, which was reviewed by the general council, is the same agreement used for other entities that attach to SEC poles.

After discussion, Trustee Anaya made a motion to approve the Pole Attachment License Agreement with Socorro Consolidated Schools; motion seconded by Trustee Bustamante. Motion carried unanimously.

Board Policy 123 - Maintenance Period for Personnel Records

Manager Herrera reported that Policy 123 – Maintenance Period for Personnel Records had been reviewed by the general counsel and the Standing Committee. Manager Herrera stated it was the recommendation of the Committee to approve Policy 123 – Maintenance Period for Personnel Records with recommended changes.

After discussion, Trustee Anaya made a motion to accept the Standing Committee's proposed changes of Policy 123 – Maintenance Period for Personnel Records; motion seconded by Trustee Wolberg. Motion carried unanimously.

Consideration of Capital Credit Estate Retirements

August 28, 2019

Manager Herrera reported that SEC General Counsel Lorna Wiggins Esq. had previously reviewed the Patronage Estate Capital Retirement as provided in the Trustee's BoardPaq.
