# **CALL TO ORDER**

The meeting was called to order at 1:59 p.m. by Luis Aguilar, Vice-President.

## **QUORUM**

Secretary Bustamante declared a Quorum of Trustees present.

## **PLEDGE OF ALLEGIANCE**

Vice-President Aguilar led everyone in the Pledge of Allegiance.

## **CONSIDERATION AND APPROVAL OF AGENDA**

Trustee Anaya made a motion to approve the Agenda as distributed; motion seconded by Trustee Wolberg. Motion carried unanimously.

Vice-President Aguilar approved the Agenda as distributed.

#### **CONSIDERATION AND APPROVAL PREVIOUS MINUTES**

Trustee Wolberg had corrections to the minutes from October 30, 2019.

Trustee Bustamante made a motion to approve the minutes from the October 30, 2019 meeting with corrections; motion seconded by Trustee Anaya. Motion carried unanimously.

## **PUBLIC COMMENTS**

Ward McCartney, District 1 Member, discussed how high the level of carbon dioxide is now compared to historical levels. Mr. McCartney reviewed some information about recent actions taken by the City of Socorro in approving Guzman Electric to provide the City wholesale power.

## **MANAGER'S REPORT**

Manager Herrera reported on the expenditure check register totaling \$705,994.41 for October 2019 and proceeded to answer questions posed by the Trustees.

Manager Herrera reported on the American Express and MasterCard credit card expenditures, with supporting receipts, as made available to the Board of Trustees for October 2019.

Manager Herrera reported for the Engineering Report, White Sands Missile Range (WSMR) will be installing a 3-year project with their contractors building the line extension while SEC is upgrading the SEC equipment. Manager Herrera stated this would improve WSMR voltage power quality. Manager Herrera said SEC had conducted 38 site visits for October.

Vice-President Aguilar thanked Manager Herrera for the Engineering Report for October 2019.

Manager Herrera concluded by reporting a group called Common Sense conducted a report comparing how Kit Carson Electric Cooperative could have saved had they stayed with Tri-State G&T. Manager Herrera stated that the group also determined that the number of renewable resources that Guzman Electric claims is not as high as reported. Manager Herrera also stated SEC had received a 4-H thank you card.

REGULAR BOARD MEETING

November 22, 2019

Mr. Williams reported on October activities as crews completed 23 work orders and closed one (1) work order. Mr. Williams stated that 57 service orders were completed, with 29 of them being for area light issues and seven (7) tree trimmings. Mr. Williams stated that Tri-State and SEC crews completed the maintenance at the Socorro Local Substation and proceeded to answer questions posed by the Trustees.

#### **OUTAGE REPORTS**

Mr. Williams gave a review of the Cooperative Response Center (CRC) Outage Report for October 2019, stating 23 outage reports had been turned in by SEC crews.

Vice-President Aguilar thanked Mr. Williams for the Operations and Maintenance Report for October 2019.

## **MEMBER SERVICES REPORTS**

#### **ENERGY DELINQUENT REPORT**

Ms. Madrid presented the Energy Delinquent Report for October 2019 as well as reviewing the collection account detail, stating that a majority of delinquencies are from medical certificates totaling \$131,756.80. Ms. Madrid explained how LIHEAP's fiscal year begins October 1st of each year, and since this time, SEC has received \$65,920.00 in assistance. Ms. Madrid stated these funds have gone to help pay member's bills. Ms. Madrid stated SEC currently has 210 members that are protected by the winter moratorium. Ms. Madrid proceeded to answer questions posed by the Trustees.

#### NM PRC MEMBER CONCERNS

Ms. Madrid reported that SEC had no member complaints filed with the NM PRC in October 2019.

Trustee Anaya reported on the Standing Committee Meeting held on November 22, 2019, with recommendations to the full Board of Trustees.

Vice-President Aguilar thanked Trustee Anaya for the Standing Committee Report.

## **NEW BUSINESS**

## Cooperative Response Center Candidacy

Trustee Wolberg requested the Board of Trustees' approval for him to submit his candidacy information to be considered for the open Cooperative Response Center Candidacy seat. Trustee Wolberg stated the position would be to finish filling out the remaining term of one year.

After discussion, Trustee Hawkes made a motion to nominate Trustee Wolberg for the Cooperative Response Center Candidacy; motion seconded by Trustee Anaya. Motion carried unanimously.

# Solar RFP Response

Manager Herrera reported the Finance Committee initially looked at submittals to the Solar Request for Proposals (RFP) for a three-megawatt system. Manager Herrera stated that if SEC were to construct or buy power from a three-megawatt solar system and were to lose the load proposed to be acquired by the City of Socorro, then SEC would be in violation of Tri-State Policy 115 – Member System Distributed Resource and SEC would be penalized for exceeding the allotted amount. Manager Herrera stated the Finance Committee requested that SEC reach out to the five companies who submitted proposals to this RFP and ask for submittal for a one-megawatt system. Manager Herrera stated it was the recommendation of the Finance Committee not to approve any of the revised responses to the Solar RFP based on the economics involved.

After much discussion, Trustee Wolberg made a motion to accept the Finance Committee's recommendation not to approve the Solar RFP responses; motion seconded by Trustee Bustamante. Motion carried unanimously.

## Power Transformer Removal

Manager Herrera reported that SEC has an old de-energized power transformer in the Socorro Local substation that contains oil with high levels of polychlorinated biphenyls (PCB) in it. Manager Herrera stated SEC received three quotations to remove and dispose of the PCB transformer properly. Manager Herrera stated it was the recommendation of the Finance Committee to accept the Solomon Corporation quote.

After discussion, Trustee Hawkes made a motion to accept the Finance Committee's recommendation to accept the Solomon Corporation quote for the Power Transformer Removal; motion seconded by Trustee Bustamante. Motion carried unanimously.

# Consideration of December 24th Office Closing

Manager Herrera reported the SEC offices would be closed on Wednesday, December 25<sup>th</sup> for the Christmas holiday. Manager Herrera stated he would like to reward the staff for a great year and asked the Board of Trustees to consider also closing the office on Tuesday, December 24<sup>th</sup>.

Trustee Anaya made a motion to accept Manager Herrera's recommendation to reward the SEC staff by also closing the office on December 24<sup>th</sup>; motion seconded by Trustee Wolberg. Motion carried unanimously.

## Consideration of Capital Credit Estate Retirements

Manager Herrera reported that SEC General Counsel Lorna Wiggins Esq. had previously reviewed the Patronage Estate Capital Retirement requests as provided in the Trustee's BoardPaq. Ms. Wiggins reviewed the retirement documents and stated that they appeared to be in order and were ready for the Board's consideration:
