## **SEC Foundation Accepting Scholarship Applications!!!** DEADLINE APRIL 3, 2023

\$8,000 Scholarships to be Awarded for 2023-24 School Year

For many years, the funds provided by the SEC Electric Foundation have been indispensable in assisting high school graduates from our service area pursue their dreams of higher education. We are pleased to announce that this benefit, available only to SEC Members, is still going strong!

The scholarship program provides awards for \$1,000 per semester which are renewable up to 8 semesters, for a total potential award of \$8,000! To renew the scholarship for each subsequent semester, the recipients will need to maintain a 2.50 cumulative GPA (on a 4.00 scale) and be enrolled as a full-time student each semester.

The scholarship funds are not an operating expense of Socorro Electric, as the funds come from unclaimed patronage capital refunds from prior years. Many times, our Members leave our service area before receiving these refunds and we are unable to locate them. We attempt to reach these members for 3 years, after which time any unclaimed funds are deposited into the SEC Foundation.

## **Socorro Crowns 2023 County Spelling Bee Winners!**


