CALL TO ORDER

The meeting was called to order at 2:01 p.m. by Anne Dorough, President.

QUORUM

Secretary Bustamante declared a Quorum of Trustees present.

PLEDGE OF ALLEGIANCE

Manager Herrera led everyone in the Pledge of Allegiance.

CONSIDERATION AND APPROVAL OF AGENDA

Trustee Aguilar made a motion to approve the Agenda as presented; motion seconded by Trustee Bustamante. Motion carried unanimously.

President Dorough approved the Agenda as presented.

CONSIDERATION AND APPROVAL PREVIOUS MINUTES

Trustee Wolberg made a motion to approve the minutes from January 27, 2021, as presented; motion seconded by Trustee Anaya. Motion carried unanimously.

President Dorough approved the minutes from January 27, 2021, as presented.

MEMBER COMMENTS

Manager Herrera reported that no Members had called in or were present for Member Comments.

MANAGER'S REPORT

Manager Herrera reported on the expenditure check register totaling \$665,327.43 for January 2021 and answered questions posed by the Trustees.

President Dorough thanked Manager Herrera for the Expenditure Report for January 2021.

Manager Herrera reported on the Visa credit card expenditures, complete with supporting receipts, made available to the Board of Trustees for January 2021, and answered questions posed by the Trustees.

President Dorough thanked Manager Herrera for the credit card report for January 2021.

Manager Herrera carefully reviewed in detail the RUS Form 7 Report for January 2021 and answered questions posed by the Trustees.

President Dorough thanked Manager Herrera for the RUS Form 7 Report.

Manager Herrera provided an update regarding COVID-19 stated Socorro County Commissioner and Fire Chief Joe Gonzales arranged for SEC employees to receive the COVID-19 vaccine, with only 11 employees participating. Manager Herrera congratulated Commissioner and Fire Chief Gonzales for the well-organized vaccine process and the ease of receiving the vaccination. Manager Herrera stated SEC had received notice that three (3) additional employees had received the vaccine through other means. Manager Herrera reported that the SEC's main lobby might open once Socorro County gets to a higher state mandated color level.

President Dorough thanked Manager Herrera for the COVID-19 Update for January 2021.

Manager Herrera provided the Engineering Report stating that the NMRECA has engaged a consultant, BKI Engineering Services, to create a coordinated wildfire mitigation plan. Manager Herrera reported that Federated insurance requires each policyholder to have a wildfire mitigation plan, and the consulting services will cost each participating cooperative \$2,500. Manager Herrera stated that ACE Drones would be flying over SEC's 3-phase taps in the northern area to inspect over approximately 200 poles. Manager Herrera stated that outages in this area are usually related to raptor birds. Manager Herrera reported that White Sands Missile Range (WSMR) had finished a new design for a mile long of a new 3-phase line. Manager Herrera proceeded to answer questions posed by the Trustees.

President Dorough thanked Manager Herrera for the Engineering Report for January 2021.

Manager Herrera reported the 2021 Credentials & Elections Committee (C&E) had met on February 10, 2021, with Committee members Bruce Brown (District 5), Chet DeMoss (District 4), Peter Gonzales (District 3), Dennis Harris (District 4), Prescilla Mauldin (District 3), Milton Ulibarri (District 3) and Chuck Zimmerly (District 3). Manager Herrera stated that Mr. Gonzales was elected as Chair with Ms. Mauldin elected as Secretary. Manager Herrera stated each committee member reviewed the notice published to all SEC members in the January 2021 Enchantment magazine, stating there were two (2) open positions for District 3 and that

members had 30-days to file. Manager Herrera stated that due to the deadline falling on Sunday, January 31, 2021, the deadline was extended to February 1, 2021. Manager Herrera stated after the C&E reviewed the qualifications of the two (2) submitted candidate applications for incumbents Leroy Anaya and Dr. Donald Wolberg, Mr. Zimmerly made a motion with Mr. Harris seconding, to accept the submitted applications. Manager Herrera reported that Ms. Mauldin made a motion to dispense with the election balloting since both open positions are non-contested and elect the District 3 candidates by acclamation, which Mr. Harris seconded. Manager Herrera stated the motion carried unanimously.

Manager Herrera stated that SEC had reserved NM Tech Macey Center for the upcoming 2021 Annual Meeting of the Members, which has some restrictions that will only allow 28 people total, including SEC and Macey Center staff. Manager Herrera reported that Macey Center would allow the SEC to use their Zoom and YouTube account to do the Annual Meeting's streaming. Manager Herrera stated SEC has also looked at getting a Zoom and YouTube account to do the streaming ourselves. Manager Herrera reported that postcards would be mailed out soon and needed to know the Board's desire on how to proceed.

After much discussion, Trustee Hawkes made a motion to direct Manager Herrera to move forward with a virtual meeting for the 2021 Annual Meeting of the Members; motion seconded by Trustee Aguilar. Motion carried unanimously.

President Dorough thanked Manager Herrera for the 2021 Credentials & Elections Committee Report.

Manager Herrera concluded by reporting that by SEC had installed Sophos, a new spam filtering process for e-mails. Manager Herrera stated the Village of Magdalena had approved the new Franchise Agreement, which includes a 3% franchise fee that is a pass-through to those members within the Village of Magdalena. Manager Herrera stated this new franchise fee would be applied to start in March 2021. Manager Herrera informed the Trustees that SEC Burris outpost had been broken into with the thieves damaging the digger truck window, costing \$1,200 to replace. Manager Herrera stated nothing was taken as all trucks and bins were locked with keys placed in a secure location. Manager Herrera reported he would be looking with an architecture to see about erecting a mason wall and gate where the trucks can be parked within the yard.

President Dorough thanked Manager Herrera for the Manager's Report for January 2021.
