PRESENTATION OF 2020 IRS FORM 990

Manager Herrera stated that Bill Miller, CPA Partner with Bolinger, Segars, Gilbert & Moss (BSGM), joined them via teleconference.

Mr. Miller thanked the Board for allowing him to present via teleconference and proceeded to go over, in extensive detail, the 2020 IRS Form 990. Mr. Miller answered questions posed by the Trustees.

MANAGER'S REPORT

Manager Herrera reported on the expenditure check register totaling \$1,060,825.06 for March 2021 and answered questions posed by the Trustees.

Manager Herrera reported on the Visa credit card expenditures, complete with supporting receipts, made available to the Board of Trustees for March 2021.

Manager Herrera carefully reviewed in detail the RUS Form 7 Report for March 2021.

President Dorough thanked Manager Herrera for the RUS Form 7 Report.

Manager Herrera provided an update regarding COVID-19, stating there were changes made with Socorro County going from the Turquoise Level to the Yellow Level under the newly revised health metrics; he stated that there might be some additional changes SEC would have to implement to remain in compliance with the new health orders. Manager Herrera stated that the lobby has been open, and all SEC staff are doing a great job of keeping everything clean with the members. Manager Herrera proceeded to answer questions posed by Trustees.

Manager Herrera provided the Engineering Report and stated that T&D Services is working on the line design for Magdalena 69kV Transmission Line rebuild. Manager Herrera stated that Mayor Rumpf asked him to present at the Village of Magdalena City Council meeting to discuss a possible route change. Manager Herrera reported that after discussing the newly proposed alternate route with the Village of Magdalena City Council, the Council approved SEC's alternate route to avoid the congested area near SEC's existing distribution lines. Manager Herrera stated that the SEC would be working with the landowners along the new alternate route to acquire right-of-ways to install the new line and answer questions posed by the Trustees.

President Dorough thanked Manager Herrera for the Engineering Report for March 2021.

Manager Herrera concluded by reporting on April 12 was Lineman Appreciation Day, and April 21 was Administrative Professionals' Day. Manager Herrera stated SEC gave the linemen and administrative staff gift bags from the Board of Trustees and management. Manager Herrera reported that all were appreciative of the gifts and thanked the Board. Manager Herrera reported that SEC had another break-in at the Burris office. Manager Herrera stated that Mr. Dettmer and himself met with DIS to see about getting cameras and looked at other options of security guards patrolling the building in the evenings and weekends. Manager Herrera also reported that the air conditioning unit within the main building's lobby has gone out and will need to be replaced.
